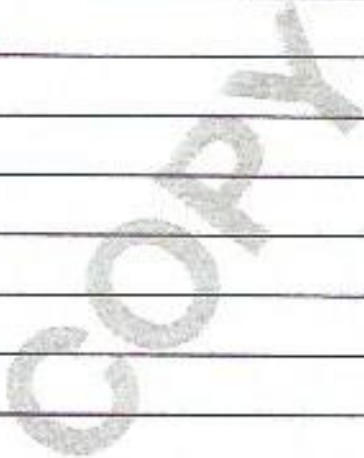

MSC'S MISSION PROGRAM BEGAN WITH THE AIM OF BRINGING THE WORLD TO CHILDREN WITH DISABILITIES. IN 2015 OVER 1,300 MISSION VOLUNTEERS TRAVELED TO MUSTARD SEED COMMUNITIES IN JAMAICA, NICARAGUA AND DOMINICAN REPUBLIC. THESE VOLUNTEERS COMPLETED PHYSICAL WORK PROJECTS AND INTERACTED WITH THE RESIDENTS OF MSC HOMES. THE MSC MISSION PROGRAM ATTRACTS SPECIALIZED AND PROFESSIONAL TEAMS THAT CONTRIBUTE TO VARIOUS ASPECTS OF THE ORGANIZATION'S MISSION SUCH AS EXTENDING MEDICAL SERVICES TO RESIDENTS, CONDUCTING TRAINING OF MSC STAFF MEMBERS AND COMPLETING SKILLED CONSTRUCTION PROJECTS.
